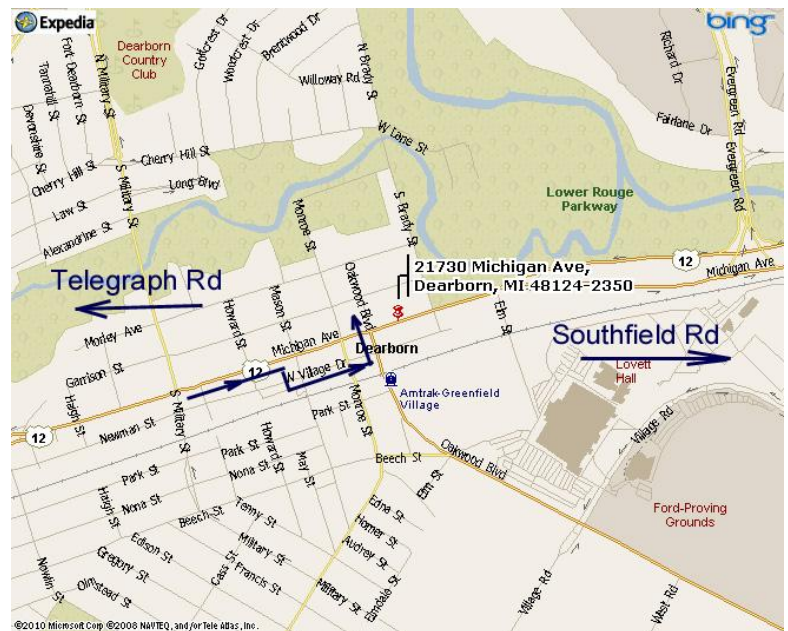

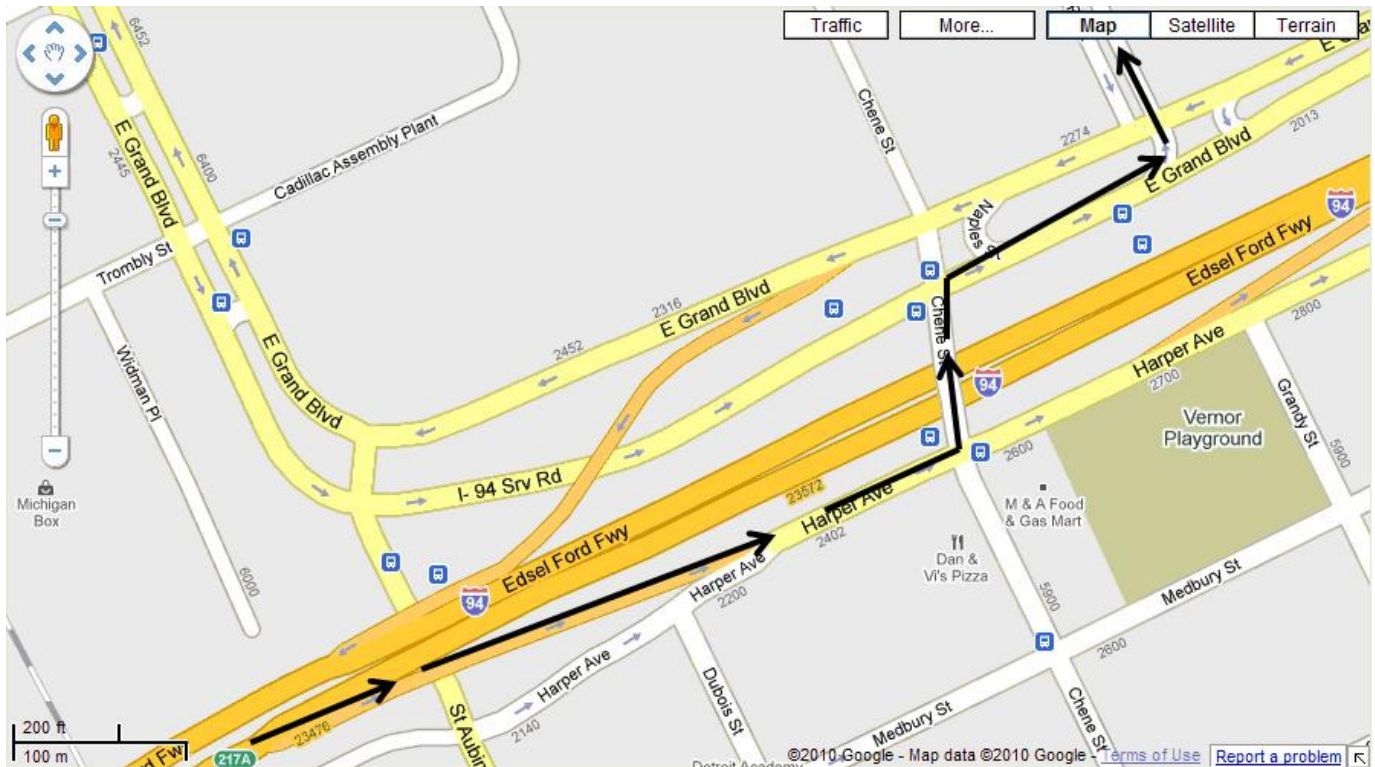

JUNE 23, 2010 MEMBERSHIP MEETING DINNER CRUISE



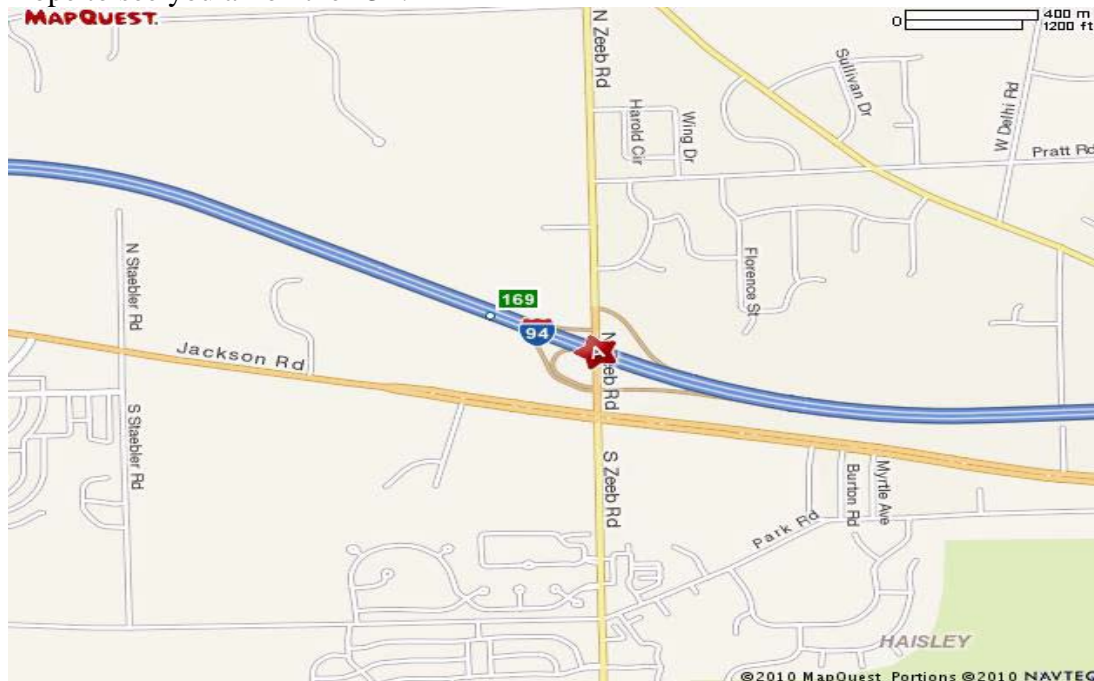
The June 23 Membership Meeting will be a dinner cruise to the Big Boy Restaurant west of Ann Arbor off I 94 at Zeeb Road.

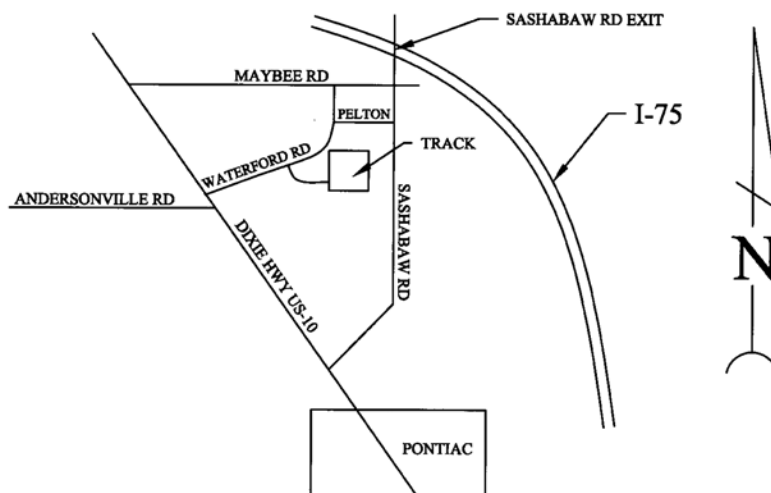
